**ORDER GRANTING FINAL APPROVAL OF CLASS ACTION SETTLEMENT**

Plaintiffs JACK WATERS and MARGARET MARA, by and through their counsel, have moved this Court for approval of the class action Settlement Agreement reached between Plaintiffs, both individually and as representatives of the certified Class. The Court having entered that Order Granting Preliminary Approval of Class Action Settlement and Form and Manner of Notice, and Setting Hearing on Fairness of Settlement (hereafter "Order") on January 5, 2007, which set forth the date for the final approval hearing, and the procedures for giving notice to the Class, the matter came on for hearing on June 20, 2007 at 2:00 p.m. Appearing at the hearing was Gavin Thornton, Esq. for the Plaintiff class, and William J. Wynhoff for Defendant.

The Court has read and considered the motion for settlement approval and related filings, and is otherwise fully informed and with good cause appearing therefore;

NOW, THEREFORE, IT IS HEREBY ORDERED:

1. The Court finds that the settlement is fair, reasonable and adequate for the Plaintiff Class.
2. Class Counsel have fairly and adequately represented and protected the interests of the Class.
3. The attorney's fees awarded to Class Counsel pursuant to the settlement agreement are fair and reasonable.
4. Notice has been provided to the Class as required by the Order.
5. No class members have opted out of the class and no class members have objected to the settlement.
6. The Court issues final approval of the Settlement Agreement.
